






Environment Protection Activities

Under Environment Protection Programme, we aim to strengthen civil society, community based organisations, youth leaugues, women groups and faith based organisations in Kenya, to influence the process of environment protection through strengthening society participation in decisions making processes in the area of climate change. This project specific aim is building capacity of leaders, to be active participators in process of policy and legislative formulation in Kenya and East Africa Community and to influence politics connected to climate change, through support of policy and legislation with focus on climate change, energy and sustainable development.

During 2021. the following activities were realized:

- •Workshop dubbed "Climate change and energy" was held in Nairobi in period of 26.-28 February 2021, where the current situation in area of climate change and Kenyan obligations in area of climate change and energy was presented;
- •In cooperation with the Ministry of Environment, a national stakeholder consultative meeting entitled "Climate change in Kenya, legal framework and plans for its implementation". was held on May 31, 2021 in Nairobi:
- •Through this project, in support of the strengthening of civil society organizations, funds were allocated for 5 projects that promoted climate change, energy and sustainable development and the role of NGOs in the process of adopting climate and energy policies.







Harnesing waste water for irrigation.

With Kenya and countries in the Horn of Africa facing drought and severe water shortage, Multi-link has started a pilot project to bring a much needed solution. For years, sewage water has proved beneficial to plants because it contains organic and inorganic nutrients. And thee nutrients include nitrogen and phosphate, which are very important for plant growth.

When you use sewage water in plants, there is a high tendency for an increase in the metabolic activities of the soil because of an enhanced soil microorganism.

The Project that has commenced in Tala region that borders Nairobi and Machakos Counties seeks to utilise low cost method of initial purification before the waste water is used for agricultural irrigation.

This will go along way is ensuring food security while conserving the environment and utilizing our scarce water resource optimaly.

CAPACITY BUILDING FOR SUB NATIONAL GOVERNMENTS AND CIVIL SOCIETY ORGANIZATIONS TO REDUCE SHORT-

LIVED CLIMATE POLLUTANTS (SLCPs)

Reduction of the SLCPs emissions is one of the varied methods and efforts of combating the adverse impacts of climate change. During the year, Multi-link with funding from Climate Works Foundation, successfully undertook and finalized the project in capacity building to reduce SLCP. The project report will be available at our website. The project was two pronged as follows:

1.Strengthen the capacity of Sub-National Entities in managing Short Lived Climate Pollutants. ir pollution is a devolved function; however, majority of Sub-National Governments have not operationalized this function. This provides an opportunity to mainstream Short-Lived Climate Pollutants into the County Integrated Development Plans, County Spatial Plans; and formulation of county air quality management policies, legislations and regulations.

2.Strengthen the capacity of Civil Society
Organizations n managing Short Lived Climate
Pollutants

Civil society organizations make a significant contribution to achieving the sustainable development agenda globally. Civil society plays a very critical role in this process and this project provided an opportunity for CSO's to share relevant and specific information and guidance, identifying gaps in knowledge, addressing uncertainties and built the capacity of CSOs, to ensure a more effective and robust actions on SLCPs.
